Chris also reports that the August BARC General Membership meeting will be held one week early on the 13<sup>th</sup> due to The Lion’s Club Festival occurring on school grounds on the 20<sup>th</sup>. BARC volunteers will be sought to help marshal the Lion’s Club Festival Parade on Saturday August 22, 2015. Convertible automobiles are also needed for the Lion’s Club dignitaries.

**Meeting Program.** Fred Stone W8LLY presented “Go Portable, Have Fun!” with Jeff Haas KD8EVS contributing a demonstration of a Buddipole portable antenna system.

**New Business:** Fred Stone announced that WKEF (TV broadcast “Channel 22”) will be changing frequencies soon due to new FCC rules. “Channel 22” (by name) is currently transmitting on channel 51 and will be moving to channel 18. The FCC is eliminating all TV broadcast channels above channel 31 and reallocating that spectrum to broadband internet and cellular telephone. The actual frequency channel is transparent to the user as the receiver equipment will assign and display the historical “Channel 22” name using “Meta Data” sent with the their signal. When the frequency change occurs, viewers need only to initiate a new channel “scan” to reset the receiver.

**Adjournment.** Fred Stone W8LLY put forth a motion to adjourn the meeting; Paul Sharp KD8OPN offered a second to the motion. The motion passed and the meeting adjourned at 8:51 PM.

**The Meeting was called to order at 7:39 by the President.**

### **Upcoming Meeting Programs:**

- **August 2015.** Don Parker – Field Day 2015 video.
- **September 2015.** Jason Bowman WG8B has offered to present his new mobile bicycle rig that he has developed for outdoor public service event communication. The bicycle featuring the “Roll-Up” J-Pole.
- **November 2015 (tentative).** Dr. Edison Fong WB6IQN inventor of “The DBJ-2: A Portable VHF-UHF Roll-Up J-pole Antenna for Public Service” as featured in the March 2007 QST. The same antenna used by Jason described above. Program would be held via Skype as Dr. Fong resides in California. Jason will contact Dr. Fong to attempt to arrange this web-based program.

**Kettering Holiday at Home Parade** is seeking ham volunteers; contact Don Parker if interested.

**BARC Website.** Jason Bowman has developed a new and modern website for BARC on a volunteer basis. He presented his work to the Planning Group this evening. Jason has developed websites for several non-profit organizations. He is using “Content Management System” (CMS) web development software called Drupal. The CMS provides centralized website development and maintenance via the internet. Content can be updated, added or removed by any authorized BARC personnel with internet access. Jason discussed all of the features that he has included in this beta version which is currently hosted on his personal web server. The Planning Group praised his work and offered many constructive ideas and additional requirements. The members present, upon further review of the beta website, will follow-up with Jason on the specifics of their ideas. Kudos went out to Jason for his excellent work.

**Antenna Project.** Fred Stone reports that the Lion’s Club Parade planning has trumped work on the antenna project. Excessive rainfall this summer has also contributed to the delay. He noted that some steel pads for antenna tower mounting are missing. Fred also described “High Sierra Raincoat Tape” for sealing exposed connectors on the roof.

**Antenna Rotor Refurbishment Project.** It was noted earlier that Jim Tiderman N8IDS has six rotors ready to reassemble. He expected to be able to complete one or two per week since his duties as Hamvention General Chairman are complete for the year. Fred and Don are awaiting a call from Jim.

**Lion’s Club Festival Parade.** Fred Stone reports that help is needed Saturday morning for the following activities:

- Setting out the line-up position numbers in the two staging areas.
- PA system setup. The PA amplifier got soaked in last year’s rain storm during the parade and needs to be repaired or replaced.
- Reviewing Stand setup. Chairs, podium and American Flag.

Don Parker will be Public Service Coordinator for this event and recruit volunteers.

A discussion was held on the status of the convertibles for the Lion’s dignitary procession. We have three confirmed and three possible. Fred will inquire as how many we actually need.

**Clubhouse Ceiling Speakers.** Fred Stone has located the speakers he intends to donate. He indicated that baffles are needed for proper mounting in the ceiling.

**Communication Center Computers.** Eric Vinande KG8NFJ inquired about upgrading the Communication Center laptops to Windows 10. It was suggested that he upgrade the laptop used for meeting presentations as a test case first.

The president adjourned the meeting shortly after 9 PM.

## **Summary—2015 Field Day Exercise**

Because of the forecast for heavy rain during Field Day weekend and the potential for flooding of BARC’s usual Sackett Wright Park Field Day Site, BARC conducted its 2015 Annual Field Day Exercise on Saturday and Sunday, June 27-28, in the BARC Communications Center.

The decision to do Field Day at the Clubhouse was made a few days prior to Field Day Saturday. Thus, the Comm Center was all set up and ready to go

when members started arriving around noon Saturday. The annual Field Day Breakfast and Lunch for the set-up crew were cancelled this year.

Although we used the Comm Center stations and antennas, we did operate on emergency power using Paul Sharp's two Honda 2-KW generators set up within the fenced area outside Comm Center.

The large "BARC Field Day / Visitors Welcome" sign was set up along South East Street at the north driveway entrance.

Five operating positions were set up for four HF stations and a 6m station. The HF stations were operated in Comm Center Stations 1, 2 and 3 and on a table near the Comm Center. The 6m station was operated in Comm Center Station 4.

BARC utilized SSB, CW and digital communications with the on-air exchange of "5 Echo Ohio" (5E OH). "Echo" is the Class designator for operating at fixed site with permanently installed antennas. However the one VHF Station is a freebie and cannot be counted. Our final Field Day Report to ARRL was submitted as a "Class 4-Echo" operation.

BARC Field Day Coordinator Darryl Fowler extends a BIG THANK YOU to everyone who attended BARC's 40<sup>th</sup> annual Field Day Exercise and helped make it another successful Club event.

Field Day certainly was different this year and everyone is looking forward to getting back outdoors for future Field Days. It's really great, though, that BARC has a Clubhouse and great Communications Center to "fall back" to when needed.

One final thought . . . , the question came up as to why BARC did not go ahead and do Field Day under the inclement weather conditions since Field Day is an emergency preparedness exercise. There are three easy answers:

1. In a real emergency situation, BARC members would "ramp up" to respond as necessary.
2. BARC's usual Field Day Site, Sackett Wright Park, sits in a flood plain right along the Little Miami River and is subject to flooding. A week earlier, the Park was covered by flood water. We did not need to risk being "trapped" in the middle of a "lake" with all of our equipment and antenna towers
3. We could have gone to another site on higher ground but we felt it prudent to not risk damage to expensive equipment (and personnel) with the in the anticipated heavy rainfall forecast. BARC has proven itself capable of responding when required and did not unnecessarily need to prove itself again.
